Recommended Action



- **The seven agencies identified on the chart above are excluded from this initiative and will remain as a separate agency within FAITAS**
- **Move the small agencies that are currently using FAITAS (and aren't already in the SEAC) in to the agency identifier "SEAC - Small Executive Agency Council" and rename this identifier as "SAC - Small Agency Council".**
 - The agencies will show as a "Bureau" under the Small Agency Council
 - The Super ACM agencies will move under SAC
- **The FAI contractor will create an identifier for any of the small agencies that currently do not use FAITAS and place those agency identifiers in the bureau list for the SAC.**
- **FAI will list the names of the six "super ACMS" in each of the agencies as the Agency Administrator, the Agency Career manager as well as the Bureau Continuous Learning Manager.**
 - In these roles each of the "super ACMS" will be able to see all requests for certification and CL Achievement Requests and select their respective sub-agencies' personnel to approve.
 - Each Super ACM and act as a back-up for another Super ACM, as needed

Timeline for Actions



- Small Agency Council - Procurement Committee Confirms the list of Agencies to be moved under the SAC
- ASMR Will move all Agencies identified by SAC/PC under SEAC and change the name to SAC
- All SAC agencies will have access to FAITAS training application
 - Workflow will go from Employee to Supervisor to Course registrar
- Certifications module
 - How many Employees currently have a certification?
 - Can the Super ACMs load these by hand?
 - If we have to do a data call in order to do a mass upload of certification Histories
- If additional Agencies are identified they will be added
